

Protection of personal data

1. The collected personal data are received by:

2. The personal data are collected from the data subject. The data subject has given consent to the processing of his or her personal data by contacting Sports Performance via email or by filling in the contact form on the website and accepting the terms and conditions and this privacy policy. Moreover, the personal data can form a necessary requirement to enter into a contract to which the data subject is a party.
3. Sports Performance uses the personal data to allow the data subject to use the services that are offered by Sports Performance. Sports Performance only uses personal data that are adequate, relevant and limited to what is necessary for the purposes for which they are processed, will be used.
4. Sports Performance undertakes to use the personal data only or to provide it to third parties for the proper management of their own contacts with the data subject or for the optimization and improvement of the services offered by Sports Performance.
5. The personal data are obtained by Sports Performance, who is responsible for the website and the management of the services that are offered through the website and who is involved in the execution and support of the services used by the data subject.
6. The personal data will be stored from the moment the data subject contacts Sports Performance either via the contact form on the website or via the email address until 1 year after contacting Sports Performance or until 1 year after termination of the use of the services.
7. The data subject has the right to request from Sports Performance access to and rectification or erasure of personal data or restriction of processing concerning the data subject or to object to processing as well as the right to data portability.
8. The data subject has the right to withdraw consent at any time, without affecting the lawfulness of processing based on consent before its withdrawal. For that it is sufficient to send an email to info@gritsportsperformance.be.
9. Sports Performance will respond to this request without unreasonable delays, insofar as this removal does not infringe a legal obligation to which Sports Performance is subject.

10. Where Sports Performance has made the personal data public and is obliged pursuant to erase the personal data, Sports Performance, taking account of available technology and the cost of implementation, shall take reasonable steps, including technical measures, to inform controllers which are processing the personal data that the data subject has requested the erasure by such controllers of any links to, or copy or replication of, those personal data.
11. The data subject has the right to lodge a complaint with a supervisory authority. For Belgium, this is the Commission for the protection of privacy (CPP: <https://www.privacycommission.be/en>).
12. The data subject is obliged to provide the personal data if he wishes to inquire or use the services offered by Sports Performance, as the personal data will form a necessary requirement to enter into a contract.
13. Where Sports Performance would further process the personal data for a purpose other than that for which the personal data were collected, Sports Performance shall provide the data subject prior to that further processing with information on that other purpose and with any relevant further information.
